## SCR disposition

5 SCRs were discussed.

1. CCB-5: "Instrument Context product - add enumerated value of "robotic arm"

Dick recommended change to SCR adding "robotic arm" to list (definition of robotic arm Change "and" to "and/or"

Corrected as suggested.

The SCR was accepted by the board based on result of votes below:

ATMOS (Lynn) – yes

GEO (Susie) – yes

SBN (Carol) - abstain

PPI (Steve) - yes

Status of the SCR will be changed to Approved-as-is.

2. CCB-6: "Terminological\_Entry.preferred\_flag: add schematron rule" Not clear what "Terminological\_Entry" is and means.

Send back for clarification and more information.

- 3. CCB-7: "Axis\_Array: remove attribute <unit>"
  There is ambiguity. Unit appears in 2 places. Not clear if it's redundant or for different purpose. Backward compatible is also an issue. Send back for clarification and clearer solution.
- 4. CCB-8: "Idd\_version\_id: modify xml schema pattern" Changing the pattern is ok but suggested solution is not the right approach. New pattern should maintain the hierarchy implicit in the 1.2.3.4 format and it should be in the schema instead of schematron. Send back for rework.
- 5. CCB-9: "Instrument\_Host Context product -- add enumerated value (with value meaning)"

Definitions need to be reworded. Dick's suggestion is a good start. SCR includes keyword must have clear definition. Send back for rework.

Board reiterated that meeting notice and SCRs must be sent out 3 days prior to meeting. In the future, SCRs will be accessible via both JIRA and a website. The website is the archive of past meeting artifacts as well as info on upcoming meeting. Lynn will email to clarify the process with links to tool/website.
